ORDINANCE NO. 2022.01

AN ORDINANCE TO AMEND CHAPTER 7 OF THE MUNICIPAL CODE REGARDING BUILDING PERMIT FEES.

THE TOWN BOARD OF THE TOWN OF BRADFORD, COUNTY OF ROCK, STATE OF WISCONSIN, ORDAINS AS FOLLOWS:

SECTION 1: Chapter 7, Section V. of the Municipal Code of the Town of

Bradford is amended and restated in its entirety as follows:

Section V. BUILDING PERMIT FEE

A. Fee Schedule. A fee schedule for all permits issued by the Building Inspector shall be as set forth in a fee schedule which shall be kept on file in the Town Clerk's office and shall be referred to as the "Building Inspection Permit Fee Schedule." The Building Inspector Permit Fee Schedule shall be considered a supplement to this code and shall be made available for reference and public inspection upon request to the Town Clerk. The fee schedule shall be approved and amended, from time to time, by resolution of the Town Board.

B. Payment of Fees. Permit fees shall be paid by the applicant prior to permit issuance. The Building Inspector and/or Town Clerk shall collect all permit fees and keep an accurate account of all fees collected.

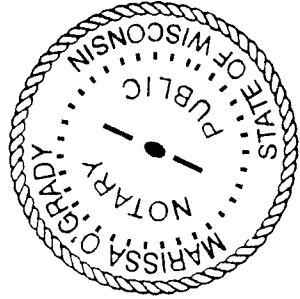
C. Delinquent Permit Penalty. Permit fees shall be doubled if any work is commenced prior to permit issuance.

D. Waiver of Permit Fees. Permit fees may be waived for buildings and structures owned by the Town if such a waiver is granted by the Town Board.

SECTION 2: This ordinance and the amendments made herein shall take effect upon passage and posting as required by law.
